- G.S.R.......In exercise of the powers conferred by the proviso to article 309 of the Constitution, the President hereby makes the following rules further to amend the Department of Science and Technology (Group 'C' and Group 'D' posts) Recruitment Rules, 1986 and Department of Science and Technology, (Group 'C' and 'D' posts) Recruitment Rules, 2001, in so far as they relate to the post of Despatch Rider, namely:-
- 1. Short title and commencement. (1) These rules may be called the Ministry of Science and Technology, Department of Science and Technology, Despatch Rider (Group 'C' post) Recruitment (Amendment) Rules, 2019.
- (2) They shall come into force on the date of their publication in the Official Gazette.
- 2. Number of posts, classification, Level in Pay Matrix. The number of said post, its classification, the Level in the Pay Matrix attached thereto, shall be as specified in columns (2) to (4) of the Schedule annexed to these rules.
- **3. Method of recruitment, age-limit, qualifications, etc.** The method of recruitment, age limit, qualifications and other matters relating thereto shall be as specified in columns (5) to (13) of the said Schedule.
 - 4. Disqualification. No person, -
 - (a) who, has entered into or contracted a marriage with a person having a spouse living; or
- (b) who, having a spouse living, has entered into or contracted a marriage with any person; shall be eligible for appointment to the said post:

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and there are other grounds for so doing, exempt any person from the operation of this rule.

- **5. Power to relax.** Where the Central Government is of the opinion that it is necessary or expedient so to do, it may, by order and for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.
- 6. Saving. Nothing in these rules shall affect reservations, relaxation of age limit and other concessions required to be provided for the Scheduled Castes, Scheduled Tribes, Other Backward Classes, Ex-servicemen and other special categories of persons, in accordance with the orders issued by the Central Government from time to time in this regard.

Note 2: The maximum age limit for appointment by deputation shall not exceed 56 years as on the closing date for receipt of applications.
