2. In case your firm is eligible & interested in the above said work, you are requested to quote your lowest prices in the enclosed Proforma in a sealed cover. The sealed cover containing the quotation should be super scribed **"Quotation for Short Time Notice Tender for water proofing treatment of the roof of S & T Block I in DST, Technology Bhavan, New Delhi-110016"** and should be dropped in the tender box kept near the Reception of Department of Science & Technology, Technology Bhavan, Shaheed Jeet Singh Marg, New Delhi on or before the **18th Aug., 2017 latest by 1500 hours**, which will be opened on the same day at 1530 hrs in Raman Auditorium (Seminar Hall), S & T Block II in the presence of such tenderers who wish to be present. The Department reserves the right to accept or reject any quotation/ estimates without assigning any reason thereof.

3. The terms & conditions of the tender is as follows: -

- a. **Eligibility condition:** -Firm/ vendor registered with CPWD and PWD can only participate. If the firm not registered with CPWD or PWD, the bid will be summarily rejected without assigning any further reason thereof(please enclose the valid registration certificate).
- b. **Rates:** -The rate should be % above or below basis on unit rate.

c. Earnest Money Deposit (EMD): -The sealed envelop must accompanied by a Demand Draft/ Pay order/ banker's cheque of Nationalized Bank for Rs.5,000/- (Rupees five thousand only) as earnest money deposit. The earnest money amount will be returned to the unsuccessful firm immediately after the award of the contract to successful bidders and the earnest money of the successful tenderer will be returned only after submission of Performance Security. Bid, not accompanied with EMD will not be considered for evaluation. No firm is exempted from submission of EMD. Unsolicited bids from parties not invited, if received, will be rejected straightway.

d. Performance security: - Successful bidders who are awarded the work order for carrying out the jobs on the basis of this Tender Enquiry shall be required to furnish a Performance Security for a period of six months (Warranty period) of an amount equal to 10% of the awarded cost of the contract (excluding statutory duties and taxes) in the form of Fixed Deposit Receipt (FDR) or Bank Guarantee from any Nationalized Indian Bank within 15 days of the award of the Contract for a period of Six months. The format for such Performance Bank Guarantee (PBG) will be provided by DST along with the work order. In the event of failure on the part of the successful bidder awarded the Contract to furnish Performance Security, EMD furnished with the Tender by such firm shall stand forfeited. The Performance Security should be made in favour of DDO, DST, New Delhi.

e. Payment terms & conditions: - Payment will be made on actual execution of work on submission of bill in duplicate to be addressed to the Under Secretary, Admin II (B), DST, New Delhi-16.

A. Location: DST, Technology Bhavan, New Delhi-16.

B. Scope, specification, quantity and quality parameters:
