Sealed Tenders are invited for Annual Rate Contract for Pest Control/Anti-Termite Treatent in Technology Bhavaan, the total area of Technology Bhavan is 15000/- Sq. Meter. in S&T Block-1, Block-2, Block-3, TIFAC Building, Cantecen Block, Telephone Exchange, Dining Room, D.G. Room, CPWD Office, Stores, Bank, Creche, Reception, Main Gate, DST Post Office, SMP Block, Facilitation Centre, Near Main Gate, CISF Barrack and space above the false ceiling etc. or any other space as desired by the Department in DST.

TERMS AND CONDITIONS

- The period of contract will be one year from the date of award of the contract which can be extended or curtailed at the discreation of the Department.
- The contractor will not be permitted to authorize any sub contractor or any other firms.
- 3. The contractor has to carry out the necessary pest control service mainly in respect of the
 - a) Rats and Borer
 - b) Mosquitoes
 - c) Flies and Flying Insects
 - d) Silver Fish
 - e) Cockroaches and other general pests
 - f) Termites etc.
- Necessary chemicals have to be used to control the pests mentioned in para 3.
- 5. The contractor will use pesticides/insecticides of bio-degradable non-toxic category which are permitted by the Govt, from time to time. The details of which may furnished along with the methodology of pest control measures proposals to be undertaken.
- 6. The chemical/ pesticided used shall be of reputed manufacturer, it should also be approved by the pest control Association for its effectiveness and safety to human beings in closed and

- The contractor has to carry out the necessary pest control service in all the Buildinigs/structures, in Technology Bhavan complex.
- The firm will be responsible for any loss, damage or liablility due to lapse on the part of its employees in the performance of his services.
- The Department will have the right to inspect the quality of work/type of equipment to be used for rendering the service. The pest control treatment shall be done in the presence & to the safisfaction of the official authorized for this purpose.
- 10. Necessary treatment has to be done on monthly basis i.e. once in a month during the period of the contract and also whenever asked for and the contractor will be responsible for removal of any dead rats and other pests.
- 11. The payment will be made on quarterly basis depending on satisfactory treatement is done. If the treatement is found to be not satisfactory, the payment due to be released only after doing satisfactory re-treatment free of cost by the contractor.
- 12. The contractor has to arrage required materials/equipments, labour etc., for the purposed and the cost thereof shall be brone by the contractor.
- Any disputes arising out of the agreement will be settled within the jurisdiction of Joint Secretary (Administration) of DST.
- DST reserves the right to reject any tender/all tenders in full or part there of without assigning any reason.
- 15. The participants have to submit the photocopy of following documents with the quotation letter
 - Certified copy of PAN card
 - ii) Proof of Name and Address of the firm
 - iii) Bank Account No. and Name of Bank with Address
 - iv) Copies of existing contracts, if any, with Govt. Departments for Pest control/Anti-Termite treatemnet.
 - v) GST Registration
- 16. Each quotation must be accompanied by a Earnest money of Rs. 10,000/- (Rupees ten thousand only) in the form of bank draft or Pay Order drawn in favour of DDO, DST, New Delhi, The EMD amount will be refunded to the unsuccessful bidders within one month of the award of the contract. The EMD will be forfeited, if the successful bidder fails to accept the contract. The EMD of successful bidder will be converted to security deposit and will only be released after two months after expiry of the contract. The security deposit will also be forfeited if the firm fails to abide by the terms & conditions of the contract.
- 17. The sealed tenders/quotations contained in an envelope superscribing "Tender for ARC of Pest Control /Anti-Termite Treatment "may be sent to the Under Secretary, Admn.II-B, Department of Science & Technology, Technology Bhavan, New Mehrauli Road, New Delhi-110016 or dropped in the Tender Box kept near the Reception Room at the entrance of the Technology Bhavan, New Delhi so as to reach the above mentioned address latest by 1500 Hrs

on 22nd September, 2017 in sealed cover, The Tender/Quotations received after due date and time, will not be accepted.

The quotation/tender will be opened on the same date at 3.30 p.m. in the presence of the authorized representatives (holding a letter of authority form the quoting firms) of such bidders who may wish to be present.
