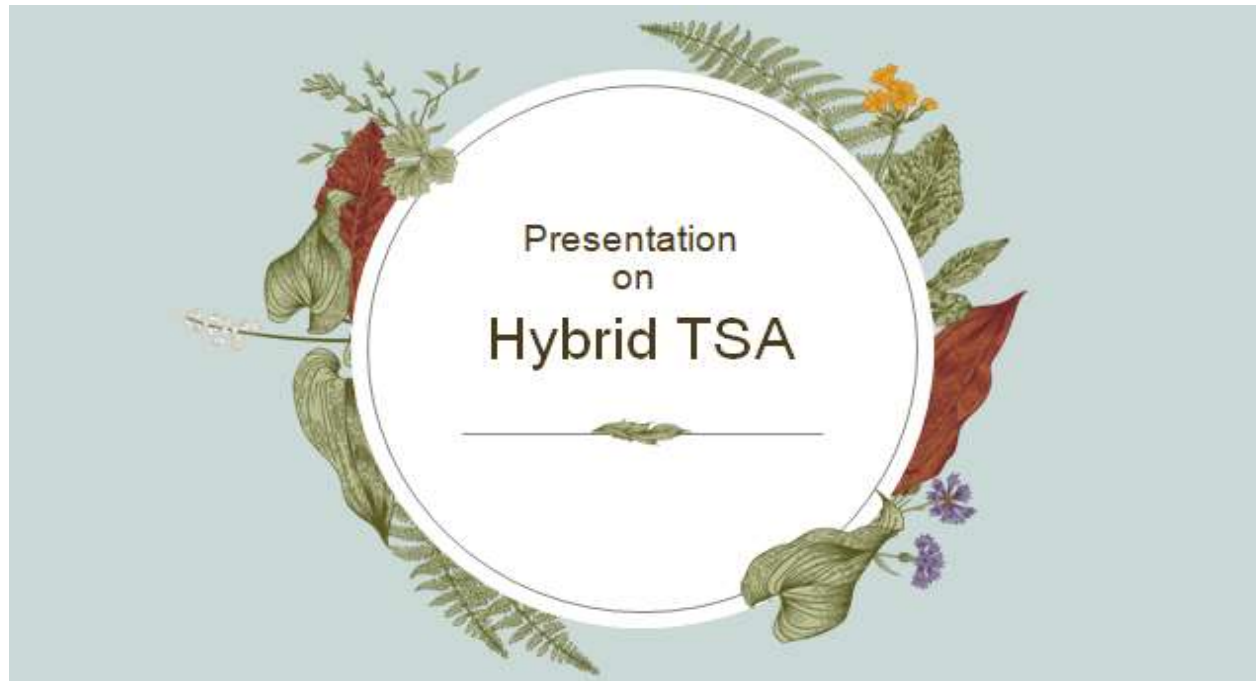

Presentation for Agencies/ Institutions for VIGYAN DHARA - 4305

Step-By-Step FOR AGENCIES WHO DO NOT HAVE THEIR ZERO BALANCE SUBSIDIARY ACCOUNT (ZBSA) IN SCB (UNION BANK OF INDIA)

- i. **Settlement of Advances** – Implementing Agency (IA) having unsettled advances need to first settle the advances against existing schemes 1817, 1819 & 3237 before on-boarding on TSA Hybrid
- ii. **New Account Opening** - IAs already not having ZBSA in Union Bank of India, need to open new ZBSA Bank account in nearest Union Bank of India branch. The Account name **must** have name of new scheme i.e Vigyan Dhara as suffix to institution name Sample: **[Eg: *Institution Name*_Vigyan Dhara]**
- iii. **PFMS Mapping** - IAs who are on PFMS will then add their bank account on PFMS with the new funding agency and scheme i.e. **TDB (unique code (TDBDST) for Vigyan Dhara (4305).**
- iv. **Forwarding to CNA DST For Mapping Approval** - Thereafter, IAs to forward the Bank mandate form , as in Annexure – I, signed by Head of Institution and countersigned by the Bank Branch Manager to CNA-TDB DST for approval. The duly signed Bank Mandate form, as in Annexure - I, is to be sent via email to CNA-TDB DST [Office-clerk3@tdb.gov.in ; accountofficer@tdb.gov.in] -along with Screenshots from the PFMS Portal indicating the successful the submission of Account Information in PFMS.
- v. **TSA Account Flagging After Mapping Approval** – After the Account Mapping is approved in PFMS by CNA-TDB DST, the IAs need to Flag their account in TSA Hybrid, as indicated in Slide 21-23. Screenshots from the PFMS Portal indicating the information and submission of the same is to be sent via email to CNA-TDB DST [Office-clerk3@tdb.gov.in ; accountofficer@tdb.gov.in] for approval.

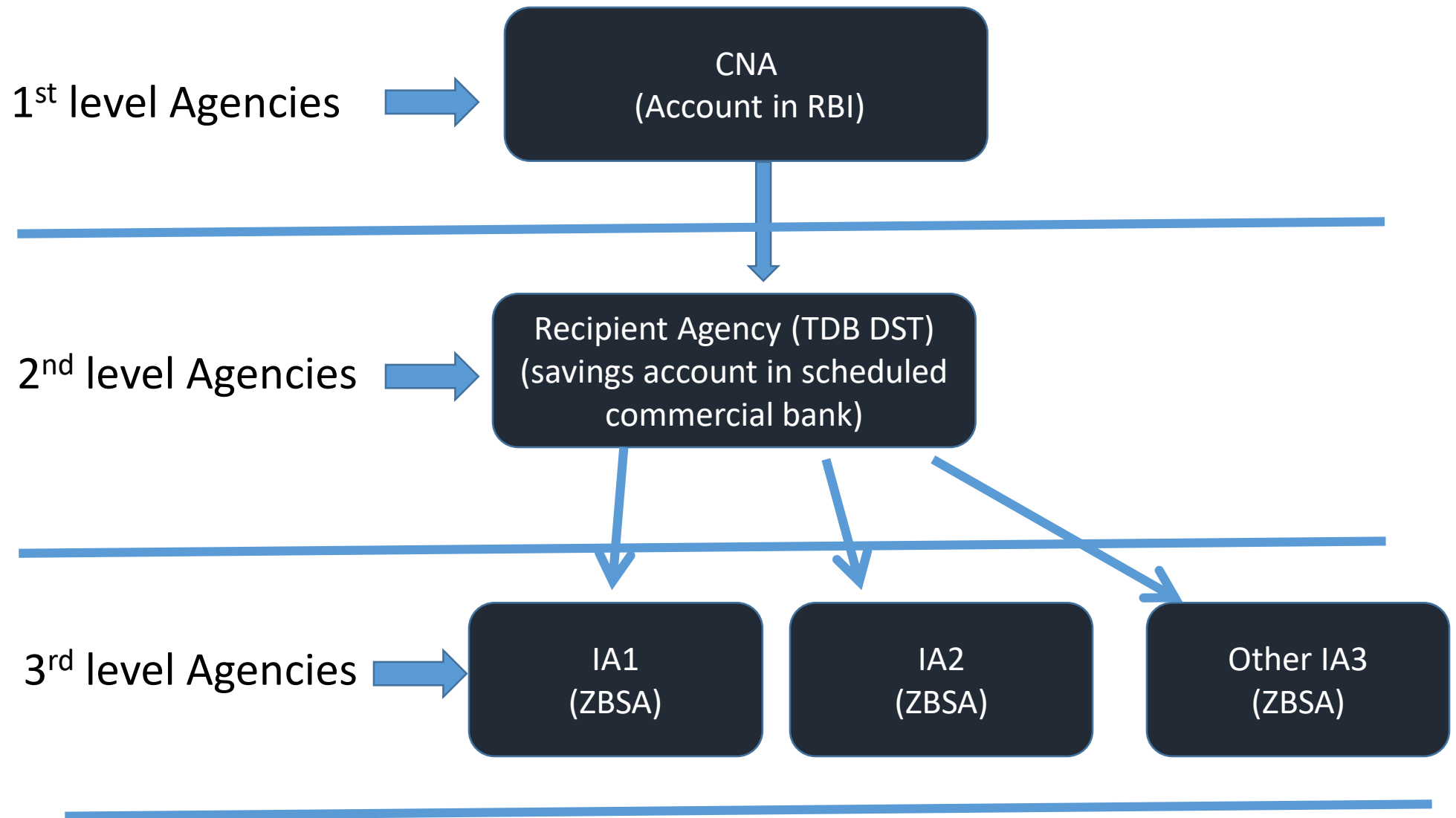

Roles and Responsibilities of Stakeholders

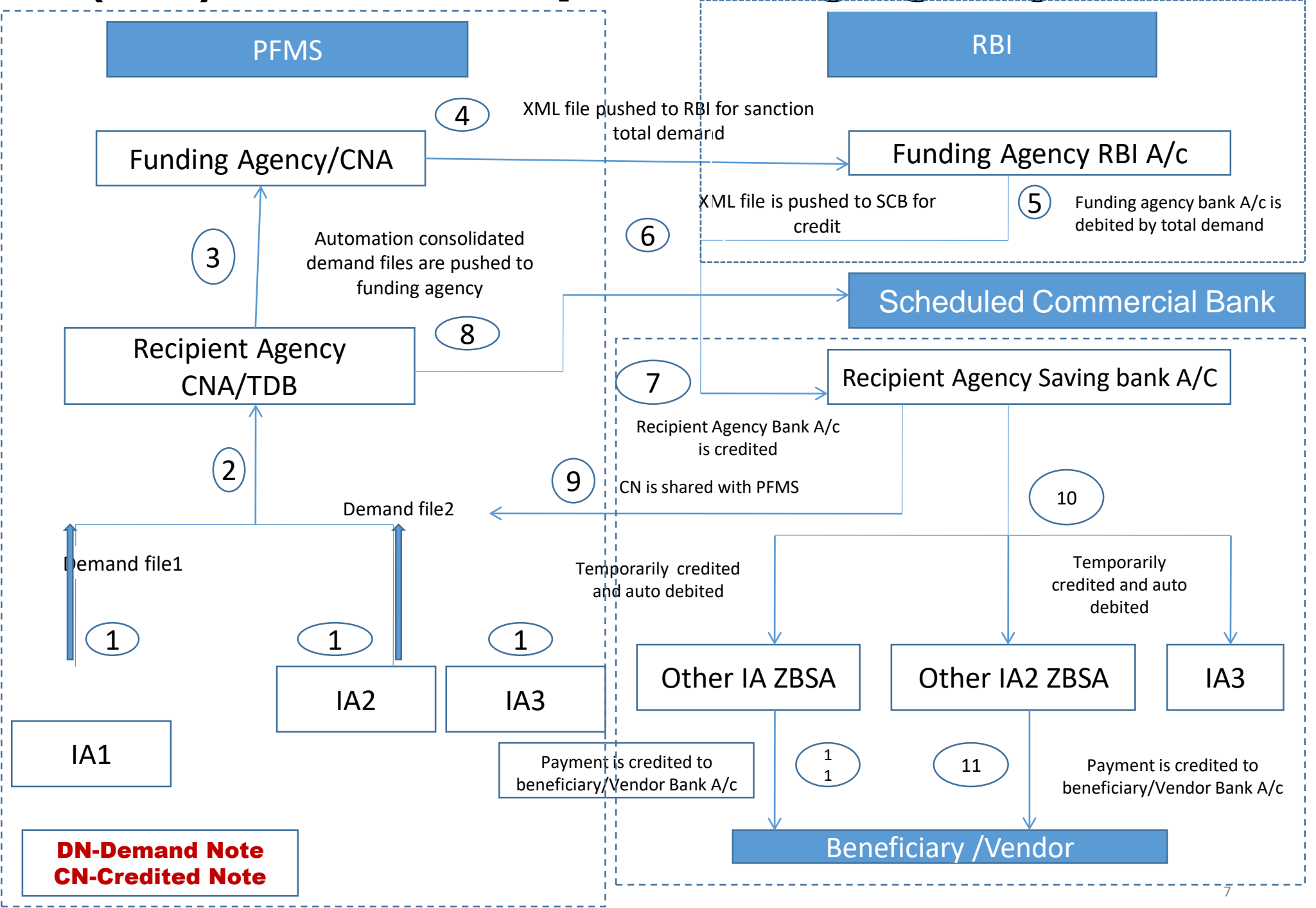
- **Sub Agencies** i.e. 2nd level Government / Private Agencies involved in the implementation of TSA Hybrid Schemes will be designated as Implementing Agencies.
- **Funding Agency** (TDB DST) is Government agencies with RBI-TSA bank Account. Funding agencies disburse funds to lower level - agencies Just-in-time as and when demand files are sent to Funding agency. Funding agencies should adhere to timelines prescribed in O.M dated 21.05.2024.
- **Recipient Agency** (TDB DST) has opened a savings bank account in scheduled Commercial bank i.e. Union Bank of India.
- **Zero balance subsidiary account** (ZBSA) All the Sub-agencies below the Funding agency will open a Zero balance subsidiary Account (ZBSA) in Union Bank of India exclusively for the scheme Vigyan Dhara (4305) only for payment purpose.
- **Holding Account** is opened for the purpose of payment of TDS, Income Tax, GST, LC to foreign vendors, scholarship to foreign student who do not have their bank a/c in SCB, salary for the month of March and other deductions including. All IAs of the scheme under TSA Hybrid shall open a **non interest-bearing Holding account in any Scheduled Commercial Bank**, in addition to the scheme account of the Implementing Agency. The transferred funds can be held for a maximum period of 14 days.

Network of CNA

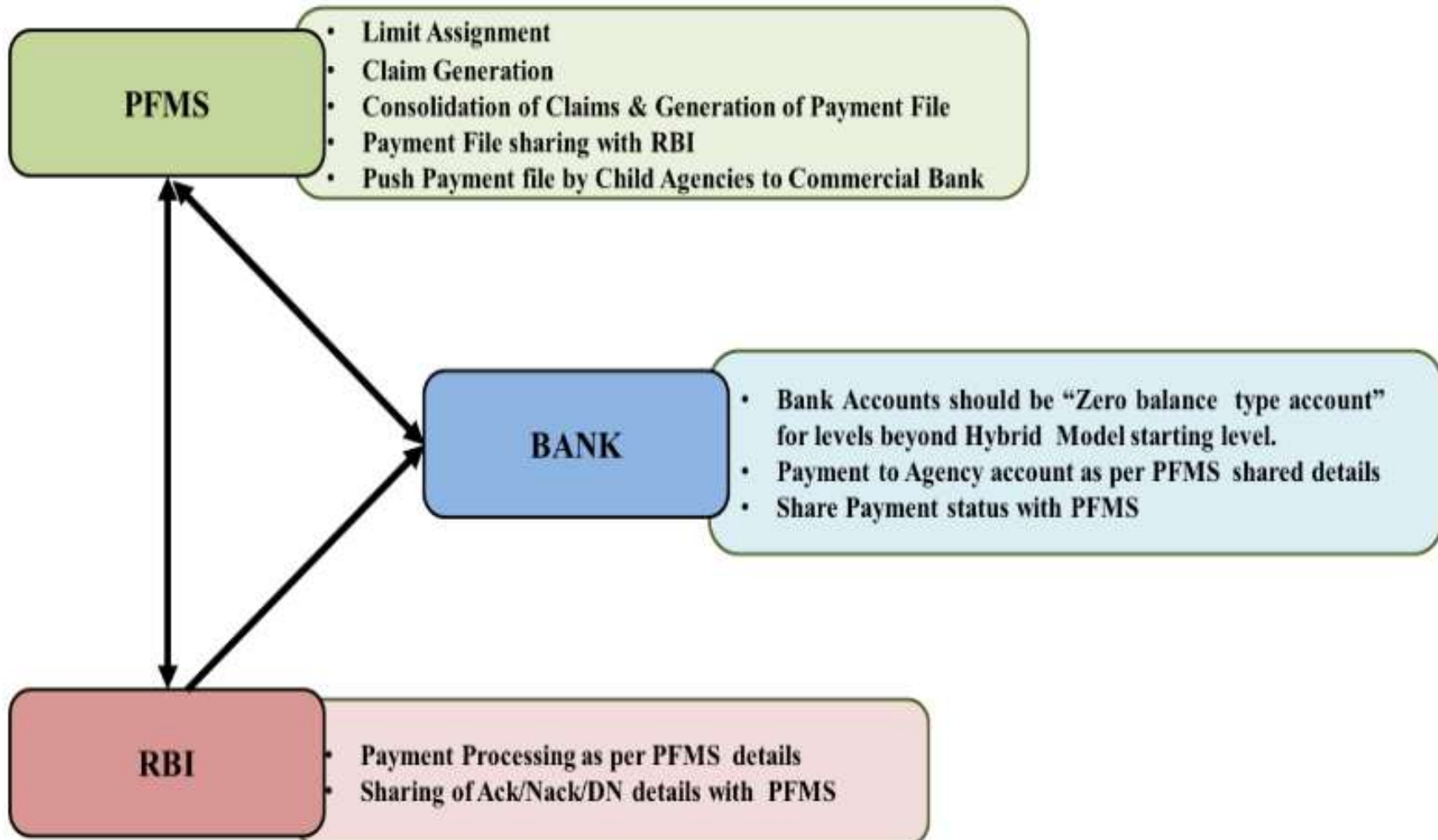
Case where CNA is funding Agency for Recipient SA at 2nd level

Funds Flow in TSA-Hybrid (TDB)

Funding Agency to act as Recipient Agency

- The CNA has to register RBI Account for acting as funding agency and flag the Savings Bank Account in Scheduled Commercial Bank as TSA Hybrid to act as Recipient Agency. Thereafter it can assign drawing limit to self as recipient agency and further assign limit to child agencies for raising claims.
- The Funding Agency / CNA will do following steps:-
 1. Register Implementing Agencies as per the scheme fund flow Hierarchy
 2. Approve their ZBSA bank account / Holding Account added by IAs
 3. IAs to do Account Flagging of ZBSA and will be approved by CNA
 4. Assign drawing limits to the Implementing Agency

Role of Implementing Agencies:

- i. IAs having unsettled advances need to first settle the advances against existing schemes 1817, 1819 & 3237 before on-boarding on TSA Hybrid
- ii. IAs already not having ZBSA in Union Bank of India, needs to open new ZBSA account ZBSA in nearest Union Bank of India duly updating the name of new scheme suffix to institution name **Vigyan Dhara**.
- iii. IAs who are on PFMS will add bank account with new scheme and funding agency will be TDB (unique code (TDBDST) for Vigyan Dhara (4305) . Thereafter, IAs have to forward Bank mandate form (as in Annexure – I) signed by Head of Institution and countersigned by the Bank Branch Manager to CNA-TDB DST for approval.
- iv. Agencies should **not use** the ZBSA account for any receipt of fund. The purpose of ZBSAs for the execution of payment only the scheme for which the account is opened and mapped.
- v. Agencies must regularly and promptly reconcile balances and financial limits on PFMS and also report any discrepancies to PFMS helpdesk for immediate corrective actions.
- vi. As soon as the funds gets transferred to top level agency corresponding to claims raised by below level agencies, PFMS will push the corresponding payment files through commercial bank of child agencies.
- vii. Funds in ZBSA of child agencies corresponding to failures to be transferred back to savings account pertaining to recipient agency i.e., agency at start of hybrid level.

Procedure to incur scheme related expenditure

The, ZBSAs will be assigned a drawing limit by the agency immediately up the ladder.

When an IA down its ladder has to make payment to vendors / beneficiaries under the scheme, the IA concerned will prepare:

- (i) a payment file in PFMS with containing details
 - (ii) demand file containing amount
-

The amount claimed in the demand file shall not exceed the drawing limits assigned to the SA.

While the payment file will be retained by the respective IA, the demand files generated by the IAs shall be consolidated daily in PFMS. The consolidated demand file will be sent to the concerned funding agency.

Procedure to incur scheme related expenditure.....

The demand received by the funding agency in PFMS till the cut-off time of 3 PM on a working day will be processed and sanction for the amount demanded will be generated on the same working day. Sanction for the consolidated demand received beyond the cut-off time of 3 PM will be generated on the next working day.

After sanction at CNA-TDB, it will be sent to RBI for debiting the assignment account in RBI of the concerned funding agency and crediting the sanctioned amount in the bank account of the Recipient Agency concerned.

Immediately on receipt of funds, the CNA will disburse them to vendors / beneficiaries through its bank account or through ZBSA accounts as per the payment files generated by respective IAs.

Procedure to incur scheme related expenditure.....

Previously, in TSA, statutory deductions like TDS, GST, Income Tax, etc. were separately settled offline. Now, the facility to settle all the deductions has been implemented, and users can also settle the deductions using the E-payment facility. This functionality is applicable for transactions done in TSA and TSA Hybrid only.
