As such, those applicants have not been shortlisted for Interview, in whose cases the experience of 20 years could not be established from the documents/certificates available in the application or representation email sent in response to DST notice dated 22.07.2024.
- 4. The eligible applicants who have not been shortlisted, may submit their representations, if any, within 15 days of publishing of this notice on the DST website. The representations are to be submitted only through email to recruitmentcell-dst@nic.in and the subject of any such representation email shall be kept as Representation/Scientist G/shortlisting status/Your Name/Your Registration Number. Representations received through any mode other than the mode mentioned above and/or after the stipulated period and/or against the

shortlisting criteria adopted by the Committee shall not be entertained under any circumstances.
