
Subject: Appointment on compassionate ground in DST for the year 2022 – reg.

3. To ensure complete transparency and objectivity in the process of selecting most deserving candidates this Department had worked out a system of allocation of points based on a hundred-point scale vide O.M. No A-12012/01/2012-Admn.I(B) dated:21/03/2013. In this scale points were allotted for various attributes like Family Pension, Terminal Benefits, Left over service of deceased, No. of Dependants, Monthly Income, Movable & Immovable Property and Financial Liabilities. In view of 07th Pay Commission the 100-point scale was revised vide O.M. No A-12012/02/2019-Estt.II dated 20.08.2019.




