**Sub:** Filling up the post of Director (Admn. & Finance) in Survey of India in Level 13 of Pay Matrix (Pre-revised Pay scale of Rs. 37,400 – 67,000 + Grade Pay of Rs. 8700) under the Department of Science & Technology on deputation basis- reg.

Sir,

I am directed to refer to your letter No. 2021/E(O)II/2/122 dated 12.08.2021 on the above mentioned subject and to say that the Competent Authority has approved the appointment of Shri Shoorvir Singh Chauhan (IRSME), Director/Carriage, RDSO, Lucknow to the post of Director (Admn. & Finance) on deputation basis in Survey of India, Hathibarkala Estate, Dehradun (Uttarakhand) in accordance with the Recruitment Rules applicable to the post in Level 13 of Pay Matrix (Pre-revised pay scale of Rs. 37,400 – 67,000 + Grade Pay Rs. 8700) for a period ordinarily not exceeding 5 (five) years, including the period of deputation in another Ex-cadre post held immediately preceding this appointment in the same or some other Organisation/Department of the Central Government, with effect from the date of assumption of charge with the following Terms and Conditions:

- (i) The period of deputation can be curtailed on the direction of the Government.
- (ii) On his appointment, he will have the option to get his pay fixed in the scale of the post under the normal rules or to draw the pay of the post held by him in the parent department on a regular basis plus deputation allowance (Duty allowance) in accordance with the instructions contained in DOP&T's O.M. No. 2/12/87-Estt. (Pay-II) dated 29.04.1988 as amended from time to time.

- (iii) He will be entitled to allowances and other privileges, as admissible to the Central Govt. servants of his class, posted at Dehradun.
- (iv) The other Terms and Conditions will be governed by relevant rules and orders of the Government of India.

2. In case, Shri Shoorvir Singh Chauhan is willing to join on deputation on the terms and conditions stipulated above, he should communicate his acceptance and report for duty at the office of Surveyor General of India, Hathibarkala Estate, Dehradun, Uttarakhand on or before 24<sup>th</sup> December, 2021.


