The scheme is being implemented by Ministry of Food Processing Industries (MoFPI). The Scheme Guidelines were issued vide OM dated 02.05.2021

- 2. Ministry of Food Processing Industries invites Applications for availing sales based incentives and grants for undertaking Branding & Marketing activities abroad under the scheme from three categories of Applicants:
  - **Category-I**: Applicants are large entities who apply for Incentive based on Sales and Investment Criteria. Applicant under this category could undertake Branding & Marketing activities abroad also and apply for grant under the scheme with a common Application.
  - **Category-II:** SMEs Applicants manufacturing innovative/organic products who apply for PLI Incentive based on Sales.
  - **Category-III:** Applicants applying solely for grant for undertaking Branding & Marketing activities abroad.
- 3. The interested entities should submit their proposals online as per the "Production Linked Incentives Scheme for Food Processing Industry" Scheme Guidelines dated 02/05/2021.
