"Fund for Improvement of S&T Infrastructure in Universities and Higher Educational Institutions (FIST) Program – 2022"

Proposals are invited online for consideration of support under the Scheme "Fund for Improvement of S&T Infrastructure (FIST)" of the Department of Science & Technology (DST), Government of India. The Scheme is intended to provide basic infrastructure and enabling facilities for promoting R&D activities in new and emerging areas and attracting fresh talents in universities & other educational institutions. It is considered as complimentary support for enabling Departments/ Centres/ Schools/ Colleges to pursue research activities more effectively and efficiently. The current emphasis on the immensely successful FIST programme is for orienting it towards the goal of Atmanirbhar Bharat by providing accessibility of the R&D infrastructure facilities not only for research activities in academic organizations but also for use by the start-ups/ manufacturing industries/ MSMEs. Appropriate mechanisms including use of the FIST facilities through multiple shifts are being encouraged through a public notice to promote optimal utilization of these resources.

Nature of Support: The Scheme will provide optimal infrastructure facilities for post-graduate and higher research, such as, renovation of existing laboratory space (no fresh constructions) and cold room, modernization of laboratories involved in PG and higher research, acquisition of essential equipment, up-gradation of existing facilities, networking & computational facilities including software & databases, scientific & technical books (no journals), maintenance & refurbishing of existing and new facilities etc.. The facilities provided under the Program are intended to support the efforts of the Department as a whole or a number of faculty members in the Department. Proposal towards individual R&D support would not be accepted under this Scheme. The synergy and focus of research may preferably be aligned to National Missions/ priorities.

Duration: The duration of support for each FIST Project will be for a period of 5 years.

Eligibility: For <u>University / Degree awarding Academic Institutions</u>, the support will be considered for the 'Department / School / Center' as a unit. All Science [under Life Sciences only traditional/ basic biological areas and excluding proposals that are pertaining to areas under modern biology (including Biotechnology, Molecular Biology, Immunology, Disease Biology etc.)] and Engineering Departments/ Centres having strong PG research programs which have existed for at least 5 years or more in universities and other higher educational institutions recognized or regulated by UGC/ AICTE and/or MHRD/ State Education Department. Educational organizations under the aegis of other Ministries/ Depts./ Agencies are excluded from the scope of FIST 2022 support.

For any repeat cycle of FIST support following an earlier FIST Project (IRRESPECTIVE of, at ANY LEVEL), henceforth all such beneficiary Department/ College would be considered for support at an appropriate level, only after a period of 10-YEARS from the DATE OF SANCTION of the IMMEDIATELY PRECEDING PROJECT as well as performance output in the previous project. However, all such Department/ Centre/ School already receiving support under FIST Program may ensure submission of all relevant documents towards final settlement and closure of the concerned project after completion of the ongoing project tenure and obtain the 'Project Completion Certificate'.

Those Departments that have completed 2 cycles of support in any particular level i.e., Level 1 (now Level B) or Level 2 (now Level C) and which would be not eligible in normal way to next higher level after 2 cycles of support may be considered for support (subject to completion of 10 years from the date of sanction of the 2nd FIST Project), only for research, with the maximum quantum equal to 50% of upper limit of support in any given category as an upper limit in 3rd cycle of support (i.e., an upper limit of Rs 1.5 crore in Level B and Rs 2.5 crores in Level C for research purposes only).

For College, the support to 'College as a whole' shall be considered for the post-graduate S&T departments only and not for other Departments i.e., Humanities, Management, Commerce etc.

Further eligibility parameters and criteria for considering a proposal for support under FIST Program are based on the type of support and are provided, subsequently.

Type of Support: Currently, there are four types of support corresponding to four different levels. These are as follows:

- (1) <u>Level 'A' (Academic-PGC)</u>: Proposals from active PG Colleges (Govt./ Govt. aided/ Private) (having eligibility as specified for Level-A) shall be considered for a maximum support of up to Rs. 1.50 crores for establishing research facilities for the S & T for 5 years duration.
- (2) <u>Level 'B' (Basic R&D Depts.)</u>: Proposals from relatively small but active post-graduate S&T Department from different Universities (having eligibility as specified for Level-B) and degree awarding academic Institutions requiring moderate funding for improving quality of research. The support would be up to Rs 3.0 crores for 5 years duration for augmentation of research facilities to a Department/ School/ Centre.
- (3) <u>Level 'C' (Contemporary R&D Depts.)</u>: Proposals from well-established S&T Department from State/ Central Universities and degree awarding academic Institutions (having eligibility as specified for Level-C) with high repute requiring substantial funding (upper limit - Rs.5.0 crores for 5 years duration) for acquiring state-of-the-art equipment & setting up laboratories for conducting internationally competitive research.
- (4) <u>Level 'D' (Distinguished R&D Depts.)</u>: Proposals from well established, internationally competitive S&T Department from State/ Central Universities and degree awarding academic Institutions (having eligibility as specified for Level-D). The upper limit of funding support would be Rs 10.0 crores for 5 years duration) for acquiring only state-of-the-art very sophisticated equipment/ facilities.

Criteria for proposals to be considered for support under FIST Program:

Level – A:

- i) Funding for PG Colleges (only for S&T related Departments) up to ₹1.50 Crore for 5 years duration,
- ii) College should have either NIRF ranking / NBA/ NAAC/ or accreditation by any other national agency,
- iii) College should have existed at least for five (5) years
- iv) The PG College should have at least 2 or more ongoing EMR grants with cumulative funds worth ₹50.0 lakhs in last 5 years,
- v) Minimum No. of students shall be- cumulative for PG Programs (15) & cumulative for UG Programs (30),
- vi) Average number of Faculty with PhD at PG level shall be 4 across all S&T Departments,
- vii) Evidence of research in the PG Department (s) of the College,
- viii) The College should have at least 4 PhD students pursuing their PhD as full time Research Scholar and receiving their fellowships either by virtue of NET/GATE qualification or holder of Institute/any other agency fellowship.
- ix) For Self-financed Private/ Govt. aided Colleges, support shall be considered on a shared basis DST share@75% and College/ Institute Management share @25 % of total project cost and/ or actual expenditure within the total project cost (whichever is less).

Level – B:

- i) At this level funding is up to ₹3.0 Crores for 5 Years duration for moderate/ basic research activities,
- ii) Departments in: a) State Universities; b) Departments applying for 1st time from Central Universities and Academic Institutions [including new IITs/ AIIMSs (established since 2014) and currently functioning in a temporary campus],
- iii) Departments in Central Universities/Academic Institutions seeking support under:
 - 1) 2nd cycle of FIST after completing 1st FIST Project need to be less than 15 years in existence.
 - 3rd cycle of FIST support (max. limit of support would be @Rs 1.5 crores and subject to completion of 10-years from the date of sanction of the 2nd FIST Project)
- iv) Departments from all IITs/ AIIMSs (other than the ones mentioned above), IISc and IISERs would not be considered for Level B support,
- v) Department should have existed at least for five (5) years,
- vi) Number of core faculty members having Ph D degree should be five (5) or more,

- vii) The Department should have at least 2 or more ongoing EMR grants with cumulative funds worth ₹100.0 lakhs in last 5 years,
- viii) The Department should have at least one (1) faculty with i-10 index of 1 publication in last 5 years,
- ix) Performance in last 5 years:
 - a) Publications, Patents etc.
 - b) Awards received by the Faculty Members of the Department/ Centre
- x) Projected Research Plan for next 5 Years,
- xi) The Department should have at least 6 PhD students pursuing their PhD as full time Research Scholar and receiving their fellowships either by virtue of NET/GATE qualification or holder of Institute/any other agency fellowship.
- xii) For Departments from Self-financed Private University/ Institute, support shall be considered on a shared basis DST share@75% and University/ Institute Management share @25% of total project cost and/ or actual expenditure within the total project cost (whichever is less).

Level – C:

- i) At this level funding is up to Rs 5.0 Crores for 5 Years duration,
- ii) Departments in: a) State Universities; b) Central Universities / All Academic Institutions / IITs, IISc, IISERs & AllMSs,
- iii) Departments seeking 3rd cycle of support (max. limit of support would be @Rs 2.5 crores and subject to completion of 10-years from the date of sanction of the 2nd FIST Project)
- iv) Department should have existed for at least for five (5) years,
- v) Number of core faculty members having Ph D degree should be eight (8) or more,
- vi) Well established Department/ Centre and should be internationally competitive,
- vii) The focus of support would be in tune with the National Missions as well as National Priorities in manufacturing, waste processing, clean energy, water and start-up India etc.,
- viii) The Department should have at least 3 or more ongoing EMR grants with cumulative funds worth ₹400.0 lakhs in last 5 years,
- ix) The Department should have at least four (4) faculty with i-10 index of 1 publication in last 5 years,
- x) Performance in last 5 years
 - a) Publications in SCI Journals, Patents etc.
 - b) Awards received by the Faculty Members of the Department/ Centre
- xi) Projected Research Plan for next 5 years,
- xii) No additional Maintenance support. Such Departments need to include/ negotiate comprehensive warranty of the equipment at the time of purchase for a maximum of 5-years period.
- xiii) The Departments of the University/ Institute should have at least 10 PhD students pursuing their PhD as full time Research Scholar and receiving their fellowships either by virtue of NET/GATE qualification or holder of Institute/any other agency fellowship.
- xiv) Support to Departments of the University/ Institute (both Govt. and Non-Govt.) shall be considered on a shared basis - DST share@75% and Grantee University/ Institute share @25% of total project cost and/ or actual expenditure within the total project cost (whichever is less).

<u>Level – D</u>:

- i) Departments in State & Central Universities /All Academic Institutions (including IITs, IISc, IISERs & AIIMSs) that are well established & internationally competitive Department/Centre in research activities,
- ii) Funding is up to ₹10.0 Crores for 5 Years duration,
- iii) Department should have existed for at least for fifteen (15) years,
- iv) The Department should have already received 2 cycles of FIST support at Level '2' and secured at least one 'Excellent' and one 'Very Good' review grading in those Projects,
- v) The focus of support would be in tune with the National Missions as well as National Priorities in manufacturing, waste processing, clean energy, water and start-up India etc.,
- vi) Minimum Number of permanent faculty members with PhD degree should be ten (10) faculty members,
- vii) At least 20% Faculty Members in the Department/ Centre shall have recognition at National/ International level such as Membership of Academies, Awards and Leadership Roles etc.,
- viii) The Department should have at least 4 or more ongoing EMR grants with cumulative funds worth ₹500.0 lakhs in last 5 years,
- ix) Measurement of Department/ Centre's profile on last 10 years' Performance:

- x) Publications in SCI Journals with citation of each publication,
- xi) Patents (Filed or Granted) and Patents exploited for commercial gain,
 - a) Extra Mural Research (EMR) Grants received from 1) National Agencies, 2) International Agencies, 3) Industry (on both Collaborative Research & Consultancy),
 - b) Full-time PhD awarded,
 - c) Recognition of faculty members from a) National and b) International agencies like Academy Membership, Awards etc.
- xii) No additional Maintenance support. Such Departments need to include/ negotiate comprehensive warranty of the equipment at the time of purchase for a maximum of 5-years period.
- xiii) The Departments of the University should have at least 15 PhD students pursuing their PhD as full time Research Scholar and receiving their fellowships either by virtue of NET/GATE qualification or holder of Institute/any other agency fellowship.
- xiv) Support to Departments of the University/ Institute (both Govt. and Non-Govt.) shall be considered on a shared basis - DST share@75% and Grantee University/ Institute share @25% of total project cost and/ or actual expenditure within the total project cost (whichever is less).

Kind Attention:

- For any repeat cycle of FIST support following an earlier FIST Project (IRRESPECTIVE of, at ANY LEVEL), henceforth all such beneficiary Department/ College would be considered for support at an appropriate level, only after a period of 10-YEARS from the DATE OF SANCTION of the IMMEDIATELY PRECEDING PROJECT as well as performance output in the previous project.

<u>For Level 'A' and 'B'</u>- All Govt. Organizations: 100% @DST Any Non-Govt./ Private/ Aided Organizations: 75% @DST & 25% @Grantee Institute

For Level 'C' and 'D'- All Organizations (Govt./ Non-Govt.): 75% @DST & 25% @Grantee Institute

PRIVATE Academic University/ College/ Institution under Not-for-Profit status and GOVT. AIDED Colleges would be considered as <u>Academic Institutions (Private)</u> option during the process of online submission of proposal.

Selection: The selection will be through a peer review mechanism and visit to the laboratories, if necessary. An Advisory Board of Experts will assist the DST in making final selection.

- 1. Log on <u>onlinedst.gov.in</u> to access the home page of the "DST e-PMS Portal".
- 2. Before filling up the form candidates are advised to carefully go through the Relevant Advertisement published at the DST Website (<u>www.dst.gov.in</u>) and also available under Proposal Formats in the e-PMS Portal (<u>www.onlinedst.gov.in</u>) after logging in the portal site.
- 3. To save your time and avoid data loss please download the appropriate proposal format as suitable for your either Department [LEVEL B/ LEVEL C/ LEVEL D] or PG College [LEVEL A], fill all the information required as per the format (Word and PDF) file (<u>max. size 5Mb</u>) and then keep it ready for upload during submission of mandatory documents.
- 4. Click on "Submit proposals" link which would take you to a page seeking multiple information starting with General information, Principal investigator etc. <u>Kindly fill the mandatory information as mentioned in the General Format of the Application. For all other documents/ information you may kindly submit the same as a part of the consolidated proposal along with application format, as appropriate for you.</u>
- 5. After filling all above particulars there is provision for preview your detail before final submission of application form on clicking on "Preview" button. Preview page will display all facts/particulars that you have mentioned on entry time if you are sure with filled details then click on "Submit" button to finally push data into server.
- 6. Candidates are advised to carefully fill and verify the details filled in the online application themselves as no change will be possible/ entertained after clicking the FINAL SUBMIT BUTTON.
