## How to check Fund allocation Status after issue of Sanction Order under the DST Vigyan Dhara Scheme (Scheme Code 4305)

- 1. Refer to the Sanction Order and keep the Sanction no. handy for reference.
- 2. The project grants are assigned through the Central Nodal Agency (CNA) (which is Technology Development Board (TDB)) under the Hybrid-TSA Model of fund flow, which takes around 10-12 days from the date of issue of Sanction Order.
- 3. The status of allocation of can be confirmed from the Implementing Agency's PFMS 'AGENCYDO' login.
  - 3.1. After logging-in, go to TSA < TSA Hybrid < New Hybrid Claims.
