- (i) The firms/persons interested in purchase of above mentioned vehicles may inspect them on any working day **from 20.10.2016 to 03.11.2016 between 04:00 PM to 05:00 PM at Technology Bhawan, New Mehrauli Road, New Delhi.**
- (ii) Closing date & time for receipt of bid: **by 03:00 PM on 04th November, 2016.**
- (iii) Bids should be dropped in the Tender Box of Admn.II(A) Section kept at Reception of Department of Science & Technology, Technology Bhawan, New Mehrauli Road, New Delhi-110016 near the entry gate. The cover of the bid documents should prominently be super-scribed with words "**BID FOR DISPOSAL OF VEHICLES**".
- (iv) Bids received till closing date & time will be opened on the same day i.e. **04.11.2016 at 04:00 PM in Raman Auditorium, Technology Bhawan, New Delhi.**

3. Terms & Conditions

- i. EMD amount as specified above for each vehicle in the form of Demand Draft drawn in favour of "**DDO, DST**" payable at **New Delhi** must be enclosed with the bid. Bids without EMD or in any other form i.e. cheque or cash etc. will not be considered.
- ii. Bidder has to deposit the EMD amount as per the combination of EMD of vehicles the bidder is interested to bid for. For example, if bidder is interested in submitting bid for vehicle at Sr. No. 1 & 3 only then he needs to deposit Rs. 4500/- as EMD amount.
- iii. The successful bidder will be required to deposit the bid amount by means of cash/DD drawn in favour of "**DDO, DST**" payable at **New Delhi within 5 working days from the date of acceptance of bid** by the department.

- iv. The earnest money of the successful bidder will be released and delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status viz. Aadhar/Voter Identity Card/Passport in case of individual and Registration Certificate in case of firms etc. Earnest money will be forfeited if the successful bidder fails to honour the bid.
- v. The successful bidder has to remove the vehicles at his own cost within three days of final payment, failing which resale of the vehicle will be undertaken at the risk and cost of the defaulter.
- vi. The vehicle will be disposed of on "As is Where is" basis and no guarantee for its worthiness or quality will be given by the Department.
- vii. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at their own cost expeditiously. The department will not be responsible for any lapse on his part in this regard.
