The meeting of the Committee constituted vide Office Order No.12012/01/2021 dated: 12th October,2021 to consider the cases for compassionate appointment for the year 2020 was held under the Chairmanship of Shri G. Srinivasan, Director. The other members of the Committee, namely, Shri P.K.Singh,Director, Shri Anil Kumar Pandey, Deputy Secretary and Dr. Krishna Kanth Pulicherla Sc. 'D' attended the meeting.

2. The committee was informed that as per DoP&T's O.M. No. 14014/02/2012-Estt.(D) dated:16.01.2013, compassionate appointments can be made upto a maximum of 5% of vacancies falling under direct recruitment quota in any Group C post. The vacancies created in the calendar 2020 falling under the direct recruitment quota in Group 'C' posts were 11. Accordingly, 01 vacancy is to be filled through compassionate appointment. The committee was also informed that for this one vacancy, a total number of 27 applicants were found eligible for consideration for compassionate appointment. 4. The affidavits and documents submitted by the applicants have been assessed by the Committee. Points secured by all the applicants out of 100 points have been calculated based upon information provided in affidavit & related documents as per the 100 point criteria, issued by this Department vide O.M. No A-12012/2/2019-Estt.II dated, 20-08-2019. The points obtained by the candidates have been tabulated as under:

A-12012/01/2012-Admn.I(B) dated, 21st March,2013 . According to which, the candidates who obtains highest marks under the parameter "number of dependents" (total of three sub categories) will be put at higher position. If still tie continues, the candidate who obtains highest marks under the parameter "Family Pension and Terminal Benefits" (taken together) shall be put at higher position. If still tie continues, the candidate who obtains highest marks under the parameter the parameter "Family Pension and Terminal Benefits" (taken together) shall be put at higher position. If still tie continues, the candidate who obtains highest marks under the parameter "Liabilities of deceased and other dependant family members" shall be put at higher position. If tie still continues, all such tied candidates would be called for interview by a Committee chaired by Joint Secretary with Welfare Officer and Deputy Secretary as members and final selection out of tied candidates would be made based on the recommendations of the Committee.

6. As tabulated in para 4 above, Shri Amit Kumar(S.No.2) & Shri Ajay Kumar(S.No.4) both have obtained highest points i.e. 59 each as per 100 point criteria of this Department. Thus having equal points of 59 the case has to be dealt as per this Department's O.M.NO. A-12012/01/2012-Admn.I(B) dated, 21st March,2013 to decide the case of tie.

7. Both the candidates, Shri Amit Kumar (S.No.2) & Shri Ajay Kumar (S.No.4) have scored equal points in the first and second criteria for deciding the tie i.e. "number of dependents" (First) & "Family Pension and Terminal Benefits". However, Shri Amit Kumar has scored one point more in the third criteria i.e. "Liabilities of deceased and other dependent family members". Therefore, the committee recommends the name of Shri Amit Kumar for appointment to Group C post on compassionate ground against the vacancy of the year 2020.
