Subject : **Constitution of Programme Advisory and Monitoring Committees (PAMC) for National Network Programme on Climate Change and Human Health (NNP-CC&HH) under Climate Change Programme of DST.**

The Climate Change Programme (CCP) – SPLICE division of DST is coordinating the National Mission on Strategic Knowledge for Climate Change (NMSKCC). As part of one of its deliverables, a few National Network Programmes (NNP) in certain key areas of Climate Change Science, adaptation and mitigation have been developed. The National Network programme on Climate Change and Human Health (NNP-CC&HH) is one among those newly developed Networks.

2. The undersigned is directed to convey the approval of the Competent Authority to the constitution of Programme Advisory and Monitoring Committees (PAMC) for the National Network programme on Climate Change and Human Health (NNP-CC&HH) under Climate Change Programme of DST.

3. The proposed composition of The National Network programme on Climate Change and Human Health (NNP-CC&HH) is as follows:-

4. The Committee will have a convener from CCP-DST who will convene the meetings of the network Programme periodically.

5. **Terms of Reference**

- i. The PAMC would review and monitor the overall progress of the projects undertaken and supported under the network programmes of Climate Change Programme of SPLICE Division as per the approved plan on regular basis and provide guidance and suggestions.
- ii. It will provide its recommendations on various projects to Expert Committee for continuation, additional support and termination if required.
- iii. PAMC will also on its own identify gap areas and actions to be initiated to address them and recommend the same to the Expert Committee for consideration.
- iv. The Committee may on the discretion of chairman co-opt any additional member during the tenure of the Committee.

6. **Tenure of Committee**

- (i) The tenure of the PAMC will be for a period of **THREE** years from the date of its meeting.
- (ii) The Chairman of all the Committees will have a term until reconstitution of EC or 3 years whichever is earlier.

7. **Payment of TA/DA**

The non-official members will be paid TA/DA as per Gol rules and given an honorarium of Rs. 2,500/- per day per sitting.
