OFFICE ORDER

Subject: Appointment on compassionate ground in DST for the years 2013 & 2014.

Reference:

- (i) DoP&T's OM No. 14014/02/2012-Estt.(D) dated 16th January, 2013 and subsequent clarifications issued by DoP&T.
- (ii) DoP&T's O.M. No. 14014/02/2012-Estt.(D) dated 05th September, 2016
- (iii) DST's O.M. No. A-12012/01/2012-Admn.I(B) dated 21st March, 2013.
- (iv) Minutes of the Committee constituted by DST to consider applications for compassionate appointment for the years 2013 & 2014.

A total of 23 applications (out of which 21 were eligible for consideration for compassionate appointment for the year 2013 & 2014 and the remaining 2 were eligible only for consideration for compassionate appointment for the year 2014) were received for consideration for compassionate appointment for the years 2013 & 2014. The vacancy for compassionate appointment for the years 2013 & 2014 were 2 and 1 respectively. All the applications were processed/scrutinised and considered by a duly constituted committee of



DST in accordance with the guidelines of DoP&T and on various parameters contained in reference (ii) cited.

2. All the 21 candidates, who had applied and were found eligible for consideration for compassionate appointment for the year 2013, were ranked based on the marks obtained by them on various parameters contained in reference (ii) cited above and information given by the applicants on affidavits submitted by them. Sh. Pankaj Kumar, S/o Late Sh. Krishna Kumar r/o House No. 505 Sector-2, R K Puram, New Delhi-22 obtained highest marks viz. 66 out of 100 & was placed at rank 1 and Smt Meena, W/o Late Sh Hans Raj Kumar r/o H No. 6054, Block No.2, Gali No.4, Dev Nagar, New Delhi-110005 obtained 2nd highest marks viz. 58 out of 100 & was placed at rank 2. However, Smt. Meena, W/o Late Sh. Hans Raj Kumar required both age & educational qualification relaxation, which is permissible as per DoP&T guidelines and was extended to her.

3. Apart from the above 2 candidates i.e., Sh. Pankaj Kumar and Smt. Meena, rest of the 21 candidates, who had applied and were found eligible for consideration for compassionate appointment for the year 2014, were ranked based on the marks obtained by them on various parameters contained in reference (ii) cited and information given by the applicants on affidavits submitted by them. Sh. Ajay S/o Late Sh. Ramesh Chand, RZ-56, Gali No. 3, Harijan Basti, Sitapuri, S.W. Delhi, Delhi-110045 obtained highest marks viz. 59 out of 100 & was placed at rank 1. Sh. Ajay S/o Late Sh. Ramesh Chand does not have the minimum educational qualification required for appointment as MTS. As of now, he is being appointed as Trainee in the – 1S pay band till he acquires the minimum educational qualification prescribed under RRs for the post of MTS i.e., 10th passed. The period spent in the – 1S pay band will not be counted as service for any purpose. Maximum time allowed for a Trainee to acquire minimum educational qualification as per DoP&T's O.M. No. 14014/02/2012-Estt.(D) dated 30.05.2013 is 05 years.



4. The competent authority has considered the recommendations of the committee and accepted the same.

5. Accordingly, approval of the competent authority has been granted for offer of appointment on compassionate grounds to Sh. Pankaj Kumar, S/o Late Sh. Krishna Kumar, Daftry and Smt Meena, W/o Late Sh Hans Raj Kumar, UDC to the post of Multi Tasking Staff and Sh. Ajay S/o Late Sh. Ramesh Chand as Trainee in accordance with the guidelines of DoP&T.

6. Sh. Pankaj Kumar and Smt Meena have already joined as MTS in this Department while an offer of appointment has been sent to the Sh. Ajay to join as Trainee in this Department.
