The undersigned is directed to state that one 01 post of Staff Car Driver (Grade-II) is to be operated at the level of Staff Car Driver, (Ordinary Grade), Group 'C' in Level-2 (Rs.19900-63200/-) and is proposed to be filled up on deputation basis from amongst regular Despatch Riders and Group 'C' employees in level-1 in the pay matrix (Rs.18000-56900) in the Department of Science and Technology & Department of Scientific & Industrial Research (DSIR) who possess valid Driving License. The pay of the selected official on deputation will be regulated in accordance with the Department of Personnel & Training's O.M. No. 2/29/91-Estt. (P.II), dated 05.01.94, as amended from time to time.

2. Eligibility conditions/qualifications, etc., required for the post of Staff Car Driver, (Ordinary Grade), Group 'C' is given in Annexure-I. Candidates who volunteer for the post will not be permitted to withdraw their names later. Nominations, which are not accompanied by the requisite personal data as per Annexure-II, along with necessary documents may not be considered. The Curriculum Vitae (Annexure-II) clearly mentioning the post applied for, duly supported by documents, will be assessed by the Selection Committee, while selecting the candidate for appointment to the post on deputation.

- 3. A Government servant holding post in higher scale of pay will not be eligible to apply for this post in terms of DoPT's O.M. referred to above.
- 4.
