

GENERAL TERMS AND CONDITION

- A. The sealed quotation should reach on or before the specified date in the enquiry letter addressed to the
Under Secretary, Admn II B, Technology Bhawan, New Delhi 110016.

THE COVER SHOULD BE SUPERSCRIBED WITH THE FOLLOWING:

- a. Reference to letter of enquiry.
 - b. Due date of opening quotation.
 - c. Supply of Material for which quotations are enclosed
- B. This office takes no responsibility for delay, loss or non-receipt of quotations/documents sent by post where as reserves the right to accept or reject any part of the tender without assigning any reasons.
- C. Corrections if any must be attested. All rates shall be indicated both in words as well as in figures, where there is a difference between rates quoted in words and figures, rate quoted in words will prevail. The firm has to submit the signed copy of the Terms and Conditions along with the quotation. The submission is for the acceptance of the general terms and conditions without which the quote would be rejected.
- D. EMD: Earnest money amounting to Rs.10,000/- (Rupees Ten Thousand Only) in the form of Bankers Cheque/ Account Payee Demand Draft of nationalized bank/ commercial Bank drawn in favour of DDO, Department of Science & Technology should accompany the tender. Tender without EMD shall be summarily rejected (EMD exemption is applicable for those who are registered with DGS&D for the said items). The earnest money should initially be valid up to 45 days beyond period of Bid validity. The earnest money of unsuccessful bidders will be returned on finalization of tender. The earnest money of successful bidders will be returned on receipt of Security Deposit or it may be adjusted in the security deposit if requested by the tenderer.
- E. SECURITY DEPOSIT: the successful tenderer shall furnish the security deposit within 2 weeks after placement of order at the rate of 10% of the order value, failing which the EMD will be forfeited automatically, to DST, without any notice. The security deposit shall be furnished in the form of Demand Draft/ FDR/ Bank Guarantee drawn in the favour of DDO, Department of Science & Technology and should be valid for 27 months. The security deposit will be returned in full on completion of successful guarantee/warranty period.
- F. RIGHT OF ACCEPTANCE: This office reserves the right to reject the lowest tender or any or all the tenders without assigning any reason whatsoever.
- G. QUOTATIONS VALIDITY: Quotation should be valid for a minimum period up to 31st Dec 2014.
- H. QUALIFYING BID: Bidders who quote lowest will be declared as qualifier on basis of L1 provided the bidder has submitted all the required documents mentioned in the tender document.
- I. GURANTEE TERMS: The supplier should provide warrantee/guarantee for minimum TWO year and onsite support. Any parts failing during the guarantee period shall be repaired /replaced free of charge by the supplier at the installation site.

J. Qualification Criteria for Vendor

1. Vendor should be either original equipment Manufacturer or Authorized dealer of reputed and established brand. **Manufacturer Authorization letter should be enclosed.**
2. Vendor should have been dealing in the LED/LCD/PLASMA display systems for past three years & supplied the same to any Ministry/Govt. Department.

K. PRICE & STATUATORY DUTIES:

1. It should be mentioned specifically whether the price quoted includes all taxes and duties.
2. Sales tax and / or other duties and levies where legally leviable and intended to be claimed should be distinctly and separately mentioned in the quotation. Where it is not done no claim for Sales Tax / Service Tax will be admitted at any later stage and no ground whatsoever.
3. VAT/CST registration No. and date of its validity should be mentioned.
4. This office will not issue any Form such as 'C', 'D' etc.

L. DESPATCH INSTRUCTIONS: The firm will dispatch the materials by road under insurance cover and freight paid by tenderer.

M. DELIVERY PERIOD: Materials should be supplied by the tenderer within 2 Weeks from the date of issue of Purchase Order at DST, Technology Bhawan, New Delhi.

n. LATE DELIVERY CHARGES: If the delivery of the material will be delayed more than specified time, 0.5% of the total amount will be charged per week subject to maximum 10% of ordered value.

o. PAYMENT TERMS:

1. Payment will be made, after completion of supply, installation & testing of the item and submitting the invoice. No advance payment will be made.
2. Payment would be in Indian Rupees.
3. Payment would be made in the name of company.

p. ADDITIONAL/Reduced QUANTITY: DST reserves the right to place order for additional quantity of the ordered quantity at the same rates and terms and condition till the validity of Quotation.

Specification for 55 inch LED Display

SCOPE:

01 Numbers of 55 inch LED displays of internationally reputed brands is to be installed at DST, New Delhi for conference room. It should include 20 meter VGA cable & VGA to HDMI converter (to connect VGA output of PC to LED display HDMI port)

GENERAL FEATURE OF THE DISPLAY UNITS:

1. The offered LED display units should fall in the category of **Smart** TV and should be of reputed international brand. Preferred brands are **Sony, Samsung, LG and Panasonic**.
2. It should meet the requirement of 24 x7 operations.
3. The LED display should be of Full HD resolution and switchable aspect ratio between 4:3 and 16:9.
4. It should have multi-format USB play out (Photo, Audio and video).
5. The offered model should be supplied with wall mount accessories and table stand. It would be the responsibility of the bidder to install (one time) the offered LED displays at the site designated by authority.
6. It should have preset picture setting/ modes like Cinema, sports, music, Vivid, natural etc.
7. It should have built in speakers with amplifier for audio monitoring.
8. LED should be supplied with full wireless handheld remote control whereas similar control should be available on LED display unit.
9. LED should have VGA port OR provision for connectivity of PC/Laptop through VGA cable
10. The offered unit should cover the manufacturer's warranty of minimum 2years.
